The equipment is accepted by the undersigned as "AS IS", together with all faults. SHYL makes no representations or warranties of any kind as to the loaned equipment. The undersigned parent/legal guardian hereby agrees to be bound by the terms and conditions of this agreement. The undersigned have read and understand the terms of this agreement and are voluntarily signing intending to be legally bound. The undersigned agree to properly care for and on a continuing basis inspect the equipment for damage or defect. The recipient of the loaned equipment shall take appropriate investigative inspection/procedure to verify that any loaned helmet is in accordance with relevant NOCSAE standards.
